1. COVID-19 INFORMATION

Important notes during the challenging times of COVID-19 Pandemic.

Proof of COVID-19 fully vaccination or printed PCR test results:

As a pre-condition to be able to participate in this event, all athletes, team delegation members and Officials must hold either a certificate of COVID-19 fully vaccination issued by the relevant competent authorities, or a COVID-19 PCR printed test result issued by an authorised health laboratories no earlier than three days before arrival.

Travel Restrictions (constantly updated)

All passengers arriving in Spain by air or sea, including those in transit to other countries, must complete a Health Control Form before their departure and obtain their QR code to present at boarding and at health controls on arrival in Spain:

By air: via the website: https://spth.gob.es or the Spain Travel Health -SpTH- application (Android, iOS). By sea (ferries): through the website: https://spthm.puertos.es/. Please check, in order to fill in the Health Control Form, if your country of departure is on the list of risk and high risk countries/areas.

If you come from a third country, please check if you can travel to Spain by clicking on: "Entry requirements for entry in Spain from third countries".

If you come from a HIGH RISK country, at the health controls on arrival in Spain, you will be required to show your SpTH QR code together with a vaccination or recovery certificate and, in addition, a SARS-CoV-2 diagnostic test certificate with a negative result.

Preliminary Inquiry & Technical Meeting (if any)

Mandatory attendance is required for **both players** of the team for the Preliminary Inquiry & Technical Meeting (if any). The detailed schedule is as follows:

The access to the location of Preliminary Inquiry will be controlled to avoid mass gathering.

Players and Delegation members are required to attend the Preliminary Inquiry and present their passports, accessories, a certificate of COVID-19 fully vaccination issued by the relevant competent authorities, or a COVID-19 PCR printed test result issued by an authorised health laboratories no earlier than three days before arrival. Failure to provide these documents will entail a disqualification of the team concerned

All players wishing to take part to a VW Beach Pro Tour Futures Event must fully comply with the requirements set by the CEV/FIVB regulatory framework.

These includes, but not limited to:

- Completed and signed the 2022 Beach Volleyball Player Participation Agreement and BVB-10 Annual Health Certificate document duly uploaded to the VIS
- have completed the FIVB anti-doping Education and Certification program
- have undertaken the <u>FIVB E-learning Course</u> on the <u>Prevention of Competition Manipulation course</u>

World Ranking Points

The awarding of the FIVB World Ranking points will be applied for this event as per the FIVB Beach Volleyball Sport Operations Manual, in case a fair access to all eligible and registered to participate athletes is ensured and will be confirmed after the issuing of the confirmed lists.

Uniform and Accessories:

The playing tops/tanks will be provided by the organiser for all Main Draw and Qualification players: 1 in the qualification; 2 in main draw; 1 for semi-finals.

Shorts/bottoms and accessories must be provided by the players and/or by their sponsors.

If required by the Technical Delegate, other uniforms and accessories will be checked during the Preliminary Inquiry. Athletes of the same team must wear the same colour and style of shorts.

The display of the individual players' sponsors' logos on shorts and accessories must comply with the FIVB Beach Volleyball Sport Operations Manual.
