1. INTRODUCTION

This Official Communication No. 1 (Registration) supports all National Federations interested in registering teams for one of the CEV Clubs competitions.

It contains important information and explanations about registration, regulations and other items for a smooth running of the competitions.

You will find a useful timeline / to-do-list in the <u>Organisation Guidelines - Chapter 1.</u> Please read it carefully.

The CEV Office is available to help, should you have any questions, or need any assistance during this process.

2. 2023 REGISTRATION PROCEDURE

Registration is done via the CEV database by completing the 01 form (one per gender), no later than:

Monday 06 June 2022 at 23:59 CET.

Once you close the 01 form, the data is fixed and cannot be changed. The CEV will set the form as 'Accepted' as soon as it is checked. When the signed and stamped originals sent by mail are received, the CEV will set the form as 'Confirmed'.

More information about your registration is available in the Organisation Guidelines - Chapters 2 and 3.

For an explanation about the access to the CEV database and its functionalities, please check Chapter 22.

3. ALLOCATION OF SLOTS

The allocation of slots per National Federation reflects the <u>CEV European Cups 2023</u> slots allocation.

With reference to the decision of the CEV Board of Administration from 21 May 2022 for the CEV Champions League Volley 2023:

If Russian and Belarusian teams remain non-eligible for participation in the upcoming 2023 Cups season until the registration deadline set for 6 June 2022, according to the CEV Volleyball Competition Regulations article 14.1 §6 d "The CEV European Ranking List", the slots assigned to Belarusian teams in the 1- 3 Rounds will remain empty. Moreover, the slots left vacant by Russia in the group stage (4th Round) will be filled in by moving up the lowerranked federations from the latest CEV European Cups Ranking lists as below: o MEN

- GER increases from 2 to 3 slots
- FRA increases from 1 to 2 slots
- SRB promoted from 1–3 Rounds to 4th Round, with one slot in the 4th Round.
- o WOMEN
 - POL increase from 2 to 3 slots
 - ROU increases from 1 to 2 slots
 - CZE promoted from 1–3 Rounds to 4th Round with one slot in the 4th Round.

By increasing the slots in the CEV Champions League as per the provisions listed above, the remaining slots for the CEV European Cups competition will be reduced accordingly in accordance with the CEV European Cups Ranking list.

In case by 01 September 2022, the suspension of the Russian and Belarusian teams is lifted, the CEV shall exceptionally expand the number of teams in the 4th Round from 20 to 24. In this case, the three registered Russian teams would be able to compete in the 4th Round and the "lucky loser" or the best ranked team not yet qualified from the 1-3 Rounds would join as additional team.

Moreover, the Belarusian teams remain not eligible to participate in the 1-3 Rounds as the DoL would have already taken place by then (28 June 2022).

CEV Volleyball Cup - information

If the Russian and Belarusian teams remain non-eligible for participation in the upcoming 2023 Cups season until the registration deadline on 6 June 2022, the following applies for the CEV Volleyball Cup:

According to the 2023 CEV European Cup Slots Allocations, the Russian Volleyball Federation has been granted one slot per gender, while the Belarusian National Federation has no granted slot.

The Russian slot will be re-allocated in accordance with article 31.3.3 c) §3 of the CEV Volleyball Competitions Regulations.

CEV Volleyball Challenge Cup - information

If the Russian and Belarusian teams remain non-eligible for participation in the upcoming 2023 Cups season until the registration deadline on 6 June 2022, the following applies for the CEV Volleyball Challenge Cup:

According to the 2023 CEV European Cup Slots Allocations, the Russian and Belarusian Volleyball National Federations have been granted one slot per gender for the CEV Volleyball Challenge Cup competition.

The Russian and Belarusian slot will be filled in accordance with article 31.3.3 c) §4 b. and 31.3.1 §2 of the CEV Volleyball Competition Regulations.

According to the CEV Volleyball Competition Regulations Article 31.1 §1,

The CEV only registers a maximum number of Clubs per gender and per National Federation, as follows:

a) 5 in all Clubs competitions

b) 3 in the CEV Champions League Volley

§2 The winning Club of a CEV Zonal Association Cup is not considered in the calculation of the maximum number of Participants for each and all Club competitions; when this club is qualified via one of the allocation options selected by its National Federation.

Therefore, the CEV Zonal Association shall until the CEV European Cups 2023 registration deadline confirm and communicate the teams that will compete in the CEV Zonal Association Cup.

The CEV Zonal Association Cup shall be finalised:

- Men until 15 September 2022
- Women 20 October 2022

4. CEV REGULATORY FRAMEWORK

During your participation in a CEV competition, you will have to use and comply with the CEV Regulatory Framework, mainly with the CEV Volleyball Competitions Regulations, Guidelines and the Official Communications. These documents are available on the dedicated section of the CEV website under documents section.

You will also have to fill in CEV forms. These forms are available in your area in the CEV database.

For a full list of the CEV forms, please check the Organisation Guidelines - Chapter 3.

The CEV Board of Administration approved new changes to the CEV Volleyball Competitions Regulations, that can been seen on a CEV website.

<u>Please be aware that by registering for the CEV European Cups season 2022/2023, you acknowledge that you have read and agreed on the terms of these Regulations and Official Communication.</u>

The allocation of teams within the levels will be made via a seeding —in accordance with the CEV European Cups ranking list and the final standing of the National Championship (after any playoffs)— and a drawing of lots.

The allocation of the "visiting" and "hosting" Club status will be in accordance with the CEV Competitions Regulations, Article 14.3.2.

11. DRAWING OF LOTS

The CEV European Cups 2023 Drawing of Lots for the CEV Champions League Volley 2023 1st – 3rd Round, CEV Volleyball Cup and the CEV Volleyball Challenge Cup will be taking place at the iconic Broadcasting Center Europe (BCE) in Luxembourg on:

Tuesday, 28 June 2022 at 12:00 CET

The CEV would have liked to welcome the clubs willing and able to attend the Drawing of Lots on-site in Luxembourg. However, according to the Government regulations in response to the COVID-19 pandemic, currently, there are limited guest allowed to attend the event. Therefore, the entry ticket will be available on a "first come first served basis".

The information about the Drawing of Lots for the 4th Round of the CEV Champions League Volley 2023 and the CEV Volleyball Gala will follow in due time.

12. USE OF LED SYSTEM

CEV Champions League Volley:

According to the CEV Board of Administration decision of 26 February 2021, the use of the LED system is mandatory from the 4th Round of the CEV Champions League Volley.

The clubs shall submit the "LED system application form" to the CEV for approval no later than 4 weeks before the start of the 4th Round.

CEV Volleyball Cup:

Static banner system as well as LED system are allowed.

The clubs shall submit the "LED system application form" to the CEV for approval no later than 4 weeks before the start of the competition.

CEV Volleyball Challenge Cup:

Static banner system as well as LED system are allowed.

The clubs shall submit the "LED system application form" to the CEV for approval no later than 4 weeks before the start of the competition.

The LED system application form is available on the CEV Cloud. The application form has to be submitted as specified in the application document.

13. COMMERCIAL RIGHTS

In accordance with the rights already granted to Club (Chapter 18 of the CEV Volleyball Competitions Regulations), the table hereafter shows the split of Advertising spaces on the Playing area between the CEV and the organising clubs.

If not used, the CEV may release one or more of the above-mentioned categories by 30 September 2022 at the latest (date due to prior contractual commitments of CEV). In any case, the categories "Betting & gambling services" and "Sports Equipment – Volleyballs" will not be released.

*For the avoidance of doubt, although the "Betting & gambling services" sector and/or category is reserved by the CEV, the Organiser may exploit, based on prior agreement of the CEV, the category for the "National lottery", provided that their sports betting operations are in

no way presented under the same brand as their National lottery operations. Thus, gambling and betting services are prohibited and the category will not be released by the CEV.

The CEV partner is the ultimate betting rights holder on a global basis in relation to the CEV Club Competitions including the CEV Champions League Volley, CEV Volleyball Cup and CEV Volleyball Challenge Cup.

14. BRANDING

For the upcoming season, all branding materials and layouts will be made available in due time after registration in the Download area on the CEV Cloud and need to be implemented by all the clubs for the season 2022/2023.

15. MEDIA RIGHTS & HOST BROADCAST PRODUCTION

The CEV is the ultimate media rights-holder of the CEV Club Competitions including the CEV Champions League Volley, the CEV Volleyball Cup and the CEV Volleyball Challenge Cup. The following media rights exclusivity and broadcasting standards which are duly stated in the CEV Volleyball Competition Regulations will apply during the CEV Club Competitions season 2022/2023:

1. CEV Champions League Volley 2023

Media Rights

The CEV Sport Media Agency Infront retains the exclusive worldwide media rights with respect to the Men & Women CEV Champions League Volley. As a result, the participating clubs <u>do not</u> <u>hold</u> any media rights in their domestic territory.

It is the responsibility of the CEV and the CEV Sport Media Agency to produce all matches of the CEV Champions League Volley season 2022/2023.

In order to ensure a professional broadcast production, the participating clubs must provide upon request to CEV and its Sport Media Agency the following facilities and services on a <u>free of charge</u> basis:

CEV -

- Camera platforms for one (1) or two (2) cameras centralised above the court and at the appropriate angle to produce a TV signal of international standard.
- A minimum number of commentary positions for each match to be located on the same side of the main camera and as close as possible to the playing field.
- Access to match data/statistics for the host broadcaster and the TV graphic operator.
- Adequate space in the TV and SNG compound for TV transmissions and production vans.
- One (1) fully furnished office for the CEV Sport Media Agency team on-site.
- Support to access the venue, TV compound and other broadcast areas.

2. CEV Volleyball Cup & CEV Volleyball Challenge Cup

Media Rights

With respect to the domestic matches only, the CEV is granting to the Participating Clubs <u>the</u> <u>non-exclusive domestic media rights</u> in the territory.

Host Broadcast Production

The participating clubs shall respect and fulfil the requirements stated in the CEV Volleyball Competitions Regulations and indicated below:

For the avoidance of doubt, any domestic matches produced by the Participating Clubs during the CEV Volleyball Cup and CEV Volleyball Challenge Cup shall respect the following World Feed signal format and signal delivery requirements:

Audio configuration	Minimum four (4) audio channels for international stereo sounds and 2 nd language commentary mix (if applicable)
Microphones	Min. six (6) including one (1) net microphone to capture atmospherics
Delivery point	Established European satellite (Eutelsat 10A or 7B)
TV graphics	Provided by the CEV and its Sport Media Agency (via FTP or cloud)

For the avoidance of doubt, the World Feed signal of each produced match must be delivered to the CEV and its Sport Media Agency <u>free-of-charge</u> via satellite according to the following standards:

- Uplink to an established European satellite
- Book the corresponding satellite space (including the end-to-end test synopsis)
- Provide an encrypted satellite feed (also called BISS code)

CEV

In order to ensure a professional broadcast production, the participating clubs must provide upon request to the CEV and its Sport Media Agency the following facilities and services <u>on a free of charge basis</u>:

- Camera platforms for one (1) or two (2) cameras centralised above the court and at the appropriate angle to produce a TV signal of international standard.
- A minimum number of commentary positions for each match to be located on the same side of the main camera and as close as possible to the playing field.
- Access to match data/statistics for the host broadcaster and the TV graphic operator.
- Adequate space in the TV and SNG compound for TV transmissions and production vans.
- One (1) fully furnished office for the CEV Sport Media Agency media and production team.
- Accommodation (full board) up to 2 rooms for the CEV Sport Media Agency staff onsite provided that they are requested minimum 2 months before the start of each match.

Lastly, comprehensive TV production manuals and on-screen graphics package will also be distributed to each participating club and appointed host broadcasters.

16. DIGITAL & SOCIAL COVERAGE

The rising of mobile phone users and social media changed the way we look at the sport of Volleyball including our engagement to that unique sport. There are many different social media platforms like Facebook, Twitter, Instagram and YouTube. Fans worldwide can use these social media platforms conveniently in their daily lives. Social media has also become an important tool for promoting events, distributing content, attracting new readers and creating more engagement to teams and athletes.

The participating clubs should use social media to promote the CEV Clubs competitions. You may find below industry standards as well as social media tips that can be used throughout the season:

- Go "behind the scenes." Make fans who are not at the event feel like they are there (and want to attend next time) by showing the scene on social media accounts. (e.g. show what the players are doing in their off time, before the game, etc.).
- Quote players: people love sharing a great quote. Make sure you use quotation marks and attribute it to the speaker.
- Think <u>quality</u> not quantity.
- Interaction between fans and athletes: when you post an interesting fact about a player, tag the athlete.
- Cross-post to other media. Make posts by attaching photos and videos of the event.
- Interact with people at the event. Share newsworthy posts by fans and credible sports journalists.

Participating clubs are also expected to engage and support the CEV Digital & TV department with the following actions:

CEV

- Promote the events via their own social media channels on a regular basis.
- Use the official competition hashtags whenever posting about it.
- Access and use CEV Social Media Graphics creator platform
- Share on their social media behind the scene photos and video footage, showing the social side of players and staff, which can be re-tweeted or shared further on by the CEV.
- Provide the CEV with additional content to distribute on social media: the best promotion comes from the players themselves.
- Produce additional video material, such as mixed zone interviews in English, for publishing across social media channels.
- Engage with the CEV and other participating clubs on social media by liking, sharing, reposting, following, retweeting content.

17. TEAMS & PLAYERS PICTURES

General Information

Team and athletes' pictures are used by the CEV for promotional purposes on its website, social media, TV graphics operations as well as to enhance the event experience for in-venue spectators with entertaining sport presentation concepts.

It is the responsibility of each participating club to provide quality pictures to the CEV based on the following requirements:

Athlete portrait shot & staff

A **portrait shot** of each registered athlete and key staff shall be provided as per the standard below:



<u>Quality standards:</u>

- Background: neutral white only
- Eyes: facing the camera
- Expression: smiling
- Hands: behind the back
- Body position: straight to the camera with shoulder visible

2. CEV Champions League Competition System – Update

Further to the Official Communication, No 1, Article 6, since a National Federation with a granted slot in the CEV Champions League Volley 4th Round – Women did not register a team to take such spot, three teams qualified through the 1st–3rd Rounds will join the group phase (4th Round) – instead of the initially announced two teams.

With eight teams registered for the 1st-3rd Rounds, the CEV has adjusted the competition system, so that the two winners of the 2nd Round will advance straight to the 4th Round while the losers will progress to the 3rd Round, where they will be playing one home and one away match. Finally, the winner of the 3rd Round fixtures will qualify for the group phase as well.

CEV Accreditation system

It is mandatory to use the CEV Accreditation System for all CEV Volleyball European Cups competitions 2023.

You can access the accreditation system via this link or via Club Area on the CEV Database.

The log-in credentials are the same used for the administration login to the CEV database. Those clubs that already used the Accreditation System may continue using old login password. The clubs that are first time accessing the Accreditation System shall confirm the account upon log-in.

Furthermore, there is a Badge Manager for the printing of the Badges for the home matches. Each club is responsible to print their players and team officials for the entire season (excluding Final phase of the respective competition). In addition, the badge can be printed on the dashboard by downloading every badge separately.

The guidelines on how to navigate through the software are available within the documents area in the accreditation system.

2. Club's logos

All clubs participating in the CEV Champions League Volley 2023 are required to upload their valid club's logo (more options and formats are welcomed) in the Database in the Club Area and on the CEV cloud in their respective folder in the upload area in vector formats (best pdf, ai or eps) by the end of August 2022 but before completing CI-S form.

3. CLS – Form (Request for approval of sponsors)

The CL-S form allows Clubs in the CEV Champions League Volley 2023 to provide the CEV with information on the sponsors as well as to receive the CEV approval for their sponsors' advertisement.

All teams shall fill in the CL-S form with all sponsors contracted for the CEV Champions League Volley 2023, bearing in mind that certain product categories are reserved for CEV (see Official Communication n°1).

For the avoidance of doubt, sponsors belonging to one of the CEV reserved categories are exceptionally only allowed on the player uniform (jersey and short), except for sponsors belonging to the category of volleyballs, alcohol and tobacco which are strictly not allowed. Approval will be indicated in the CLS form with "sponsor only allowed on uniforms".

The CL-S form will be available online in the CEV Database from 8th August 2022.

All clubs have to duly fill, save, close and send the CL-S form to CEV via the CEV database before the start of the competition <u>and no later than</u>:

- Friday 2nd September 2022: for men's teams participating in 1st to 3rd Rounds
- Friday 30th September 2022: for women's teams participating in 1st to 3rd Rounds

- Friday 14th October 2022: for men's teams participating in the 4th Round
- Friday 18th November 2022: for women's teams participating in the 4th Round

4. Commercial Rights (update 1st to 3rd round incl.)

For the teams participating in the 1st to 3rd Round (incl.) CEV is ceding the following number of positions:

- 3 banner positions
- 2 floor stickers (F1 + F6)
- 10% of the LED system timing (in case of dynamic rotation)

For 4th round participants, further information in case of release of LED timing percentage will be published in the next Official communication after 30th September, as stipulated in O.C. n°1.

CEV reserved product categories:

Please refer to the Official communication n°1 for further information.

As a reminder, "Betting & Gambling" sponsors are not allowed in the frame of the CEV Champions League Volley, <u>except</u> for one sponsor logo on the player jersey.

5. Application for LED system

As a reminder, the use of LED system is mandatory as from 4th Round.

All teams shall download the LED system application form from the CEV cloud <u>https://cloud.cev.eu/url/ledapplform20</u> and submit the compiled form in the club's folder in the Upload area on CEV cloud.

The LED playlist will be available for downloading on the CEV cloud.

6. Team Uniforms

When ordering the team uniforms, clubs must make sure they are produced according to the CEV Volleyball Competitions Regulations and CEV Organisation Guidelines for Clubs.

All teams are requested to proceed as follows:

1. SPONSOR APPROVAL:

All sponsors appearing on the uniform shall be approved by CEV through the CLS form. 2. TEAM UNIFORM APPROVAL:

Any approval of team uniform shall only be valid if all sponsors are uploaded and approved in the CLS form. The uniform may be formally approved in case the production of the latter is launched before the activation of the form in the CEV database.

After approval of the sponsors through the CLS-form, teams are required to upload the layout in colour of their 2 sets of uniforms, shirt and short, with a front side and back side view into their club folder created on the CEV cloud.

CEV must be informed of the upload by a short email to <u>graphics@cev.eu</u>.

3. COMPETITION LOGO BADGE:

The CEV Champions League Volley 2022 badge has to figure on the team uniform as from the first match, namely on the right sleeve for jerseys with sleeves or on the upper right chest for jerseys without sleeves (see layout hereafter).

Clubs have two options:

1) Order the new competition logo badges via the CEV Office. The deadline for ordering such badges is set for Friday 12th August 2022, by sending an email with the exact number of badges needed to: <u>marketing@cev.eu</u>.

2) Integrate the competition logo during production of the jerseys. Teams shall download the new competition logo from the CEV Cloud.

Production of banners (including CEV positions), backdrop, poster, digital promotion and tickets is compulsory. Any other promotional material with CEV identification markers shall be uploaded for approval.

Please note that we do not provide any ticket and brochure / Programme layouts. However, all the relevant information and logos must be included in the design layout produced by the clubs, namely CEV logo, competition title and logo, CEV Official partner's logo. The production of an official brochure / official program is not mandatory.

All graphics will be available for downloading from the CEV Cloud. All Organisers have the opportunity to review the basic Brand Guidelines, to download and use the official competition logo and graphic devices in various formats, as needed.




Following to CEV Volleyball Competitions Regulations and Champions League Volleyball Brand Guidelines all clubs participating in the Champions league Volley 2023 are requested to design the court layout according to the condition displayed hereafter.

All **floor stickers** must be produced with an identical approach and style. Identical style means, if possible, similar background for floor stickers F1, F2, F5 and F6 (recommended are transparent or darker backgrounds). Floor stickers with white background should be avoided. Floor stickers F3 (competition title) and F4 (Host city) are <u>mandatory</u> and must always be presented with transparent background. Host City must be promoted in writing and in white color (no city logo).

Net post paddings can be provided with or without cover banner by using the brand pattern design available as a template in the CEV cloud (for more details see the visualization further in this document).




Court layout up to 3rd round 10.

1. Commercial Rights

As announced in the Official Communication n°1 and in case no CEV partner is contracted by 30 September 2022 (date due to prior contractual commitments of CEV), one or several reserved categories may be released by CEV, on a non-exclusive basis.

RELEASED PRODUCT CATEGORIES

The following product categories are released from 4th Round up to ¼ finals <u>on a non-exclusive</u> <u>basis</u>:

- 3. Body & healthcare products
- 4. Courier services & logistics

RESERVED PRODUCT CATEGORIES

The CEV reserves the following product categories:

- 1. Betting and Gambling services
- 2. Sports Equipment Volleyballs

LED SYSTEM COMMERCIAL RIGHTS' SPLIT

As a reminder, the use of LED system is mandatory from the 4th round and the LED application form must be sent in for approval.

The CEV is ceding 10% of its LED timing to the clubs with the split being 70% CLUB/30% CEV.

2. Reminder – LED system application approval

All LED system applications have to approved by CEV at the latest by Monday 21st October.

CEV is in the process of preparing LED footage for all clubs and the files will be made available in the CEV cloud "download area" before the start of the 4th Round. The use of these files is mandatory.

3. FIVB Education Programme

Referring to the CEV Volleyball Competition Regulations Article 83 §4:

The Team manager shall present to the relevant CEV Official the following elements: a. For each Team delegation member:

i. The FIVB Anti-Doping education programme certificate, ii. The FIVB Competition Manipulation Course certificate, iii. The accreditation card.

Following that, we received information from the FIVB that the VIS platform is ready to execute the certificates. For those officials that do not have access to the VIS platform, the Federation of Origin shall register the official on a platform.

Given that, we inform you that starting from 1 November 2022, and it will be obligatory to have the certificates for the CEV Competitions.

4. CEV Service Operator Management

1. Mikasa Promotional Balls

Each team qualified for the Champions League Quarter Finals will receive 80 miniature (promotional) balls. The model (code) of the balls is V1,5X-CEV. Each club will be responsible for bearing any import duty and taxes related to the shipment.

An email has been circulated by the CEV Office to the Organising Director of each qualified team to collect the full delivery information for the shipment coming from Asia.

2. Challenge Referees

It has been decided that from the Quarter Finals onwards the European Refereeing Commission (ERC) will appoint a dedicated and specific **Challenge Referee** for each match. According to the CEV Volleyball Competitions Regulations, Chapter 1, Section8 §30, the Challenge Referee is fully part of the match officials, and is a different person from the 1st Referee, the 2nd Referee, the Reserve Referee, and the Referee Coach.

The appointed Challenge Referees will be visible in the CEV Database, at the bottom of the 08 form, in the *"General Team Communication"* box. Their contact details and departure airports can be retrieved through the CEV Yellow Pages.

3. Match Media Activities

During the CEV Champions League Volley Playoff, Quarter Final and Semi-Final matches, each qualified team shall support the following media activities with the aim to provide a more immersive experience and bring Volleyball closer to the fans:

1. Pre-Match interview (1x player or 1x coach of each Club)

- When: right after filming teams' arrival or 45 mins before the match
- Responsible: club's media officer & host broadcaster
- Language: English (1 or 2 questions maximum)
- Duration: max. 45 seconds per interview

2. Coach interview (the coach of each Club)

- When: in between sets 2-3
- Responsible: club's media officer & host broadcaster
- Language English (1 or 2 questions maximum)
- Duration: max. 45 seconds per interview
- 3. Post-match interview (1x player or 1x coach of the winning team <u>only</u>)
 - When: at the end of the match (flash interview area or mixed zone)
 - Responsible: club's media officer & host broadcaster
 - Language: English (1 or 2 questions)
 - Duration: max. 45 seconds per interview

All the above media activities are performed in close collaboration with the appointed CEV Supervisor on-site and the CEV Sport Media Agency Infront. The host broadcaster will also record the arrival of the teams to the venue and short locker room scenes.

4. Led Play list – Quarter Finals update

For the CEV Champions League Volley starting from the Quarter Finals, each qualified team shall download an updated LED playlist, complete, and upload it again on the CEV Cloud for approval. The updated LED playlist follows an identical structure but includes refreshed CEV content. All CEV LED animation footages will be available for using in the download area of the CEV Cloud.
